Note:

Chinese documentation must be translated into Italian, notarized by local notary public office and legalized by the competent Foreign Affairs Office.

Attention:

Please note that only if you will stay in Italy for longer time than in any other Schengen countries, you can come to IVAC to apply for short-term Schengen visa. Instead, please go to the respective Consulate in Shanghai of other Schengen country where you will stay for longest time to apply for visa. Otherwise the border Schengen police may reject your entry request and expel you from Schengen area.

请注意，前往意大利签证申请中心申请短期申根签证，在意大利逗留的时间必须长于其他申根国家；反之，请去逗留时间最长的国家的驻沪总领事馆申请签证。否则，申根边防警察可以拒绝您的入境请求并将您驱逐出申根地区。
